The Pupil Premium

This report outlines how our school has spent the Pupil Premium allocation in Budbrooke and how it plans to spend it in the forthcoming academic year. It also outlines the progress that children in receipt of the pupil premium last year made across areas of reading writing and mathematics. It also outlines our key principles and reasons for spending the Pupil Premium in the way that we do.

Our Principles and Objectives

The Pupil Premium was introduced to address the underlying inequalities between children eligible for free school meals and their peers. It is allocated to schools to work with pupils who have been registered for free school meals at any point in the last six years.

School are free to spend the Pupil Premium as they see fit, however, our approach and vision for our pupils is to ensure that all are offered '**rich opportunities and memorable experiences**' and that those from poorer socio-economic backgrounds do not suffer barriers which hamper their progress and attainment.

Our decisions on how best to use the 'Pupil Premium' are based on the findings of high quality research and publications, as well as OFSTED's own 'best practice' guides. These have supported our decision on expenditure over the best and most effective use of our Pupil Premium Funding. We are also aware that the unique features of our local economy, results in significant numbers of our parents not being eligible to claim for free school meals.

We believe that:

- All of our children should and will benefit from the teaching and learning opportunities that Pupil Premium funding provides
- Appropriate provision is made for all pupils belonging to vulnerable groups, including those who are from socially and economically disadvantaged groups
- Pupil premium spending should be allocated following a needs analysis which identifies children with priority needs; those with the greatest need being children in receipt of free school meals whose progress is not rapid enough
- Pupils who receive free school meals are not necessarily socially disadvantaged or are making inadequate progress
- Not all pupils who are socially disadvantaged are registered or qualify for free school meals
- Our Pupil Premium funding should be spent in a wide and imaginative variety of ways, so as to benefit the wide variety of interests and needs of our children
- Our Pupil Premium funding should be spent according to 'best value principles' and related to activities which research suggests will make the very best use of the finances available
- Whilst there are some 'quick wins', there is a need to also take a 'long term view' to stop achievement gaps from widening. Some of our long term objectives will take more than an academic year to come to fruition.

Impact Statement - Educational Progress and Attainment

The effect of this expenditure on the educational attainment of those pupils at the school in respect of whom grant funding was allocated.

How impact is measured:

- All children's attainment and progress from individual starting points is tracked and monitored against national and school expectations (in addition to progress being measured in lessons)
- All disadvantaged children eligible for the pupil premium grant are monitored closely and individual barriers to learning are recorded and addressed (this may include barriers to learning that are not academic in nature)
- Attendance and punctuality is continually checked
- Engagement of parents in school events (parents evening, homework club etc.)

Results at the end of 2017-18 the attainment and progress of Pupil Premium Pupils show improvement:

- (NB: there are very few PPP and all are in different year groups. This means that each child's results makes a huge difference to our analysis)
- Internal data shows that in writing the majority of Pupil Premium Pupils are making expected progress
- Internal data shows that in maths the majority of Pupil Premium Pupils are making expected progress
- Internal data shows that in reading the majority of Pupil Premium Pupils are making expected progress
- There was one PPP who took KS2 SATs and achieved the Expected Standard in writing.
- Two PPP took the KS1 SATs and achieved either the Expected Standard in all three areas or Greater Depth.

Our Pupil Premium Funding 2018-2019

Total number of pupils on role: 241
Total number of pupils currently eligible for Pupil Premium Grant: 5
Total amount of Pupil Premium Grant per pupil: £1320
Total amount of Pupil Premium Grant: £6600

Pupil Premium is calculated from the Spring Census so to receive funding in September 2018, the child would have needed to have been eligible for Pupil Premium Funding in January 2018 and on roll at this school.

Our Targeted Areas

In order to improve the progress and outcomes for Pupil Premium pupils we aim to:

- Ensure all pupil children are meeting age related expectations and making at least expected progress from their starting points
- Provide resources to support improved access to learning opportunities
- Enrich the lives of those on Pupil Premium, opening doors and creating new opportunities
- Develop support for Pupil Premium pupils and their parents beyond the school gate

Main Barriers to Educational Achievement

Generally, at Budbrooke, the main barriers disadvantaged children face are:

- Low income
- Unsettled family arrangements
- Emotional instability of family member(s)
- Parents may not have had a successful or enjoyable education
- Children / siblings may have had disrupted educational experiences
- Safeguarding concerns
- Lower than average attendance and lateness
